Resolution Honoring the Leadership and Service of DNC Hispanic Caucus Chair Emerita Iris Martinez

WHEREAS, Iris Martinez served as a DNC member from Illinois since 2000 and as Chair of the DNC Hispanic Caucus since 2008, under the leadership of seven DNC Chairs; and

WHEREAS, during her time on the DNC and in her role as Chair of the DNC Hispanic Caucus, Martinez has been a leading voice within the Democratic Party, advocating for Latino voters and issues that affect the community; and

WHEREAS, as Chair of the DNC Hispanic Caucus, Martinez traveled across the country to states and territories including Arizona, California, Florida, New York, New Mexico, Nevada, Pennsylvania, Puerto Rico and Texas to highlight the work of the Caucus; and

WHEREAS, under her leadership as Caucus Chair, Martinez created an inclusive executive board by elevating members to represent their respective regions; and

WHEREAS, since her appointment to the DNC Rules and Bylaws Committee in 2008, Martinez has played an important role in helping support and modernize the Democratic National Committee and its outreach to and inclusion of Latino voters; and

WHEREAS, in 2003, Martinez was the first Latina woman elected to the Illinois State Senate and worked with colleague Barack Obama until he was elected to the U.S. Senate, and where she served until 2020; and

WHEREAS, in 2020, Martinez won election as the Cook County Circuit Clerk and became the first Latina to serve in the position and the second woman of color to hold the position; and

WHEREAS, Martinez has been a part of five Democratic National Conventions, of which two nominated a woman for president, and helped to uplift Latino leadership and voices;

THEREFORE BE IT RESOLVED, that the Democratic National Committee celebrates Iris Martinez for her leadership and service on the Democratic National Committee and as Chair of the DNC Hispanic Caucus.

Resolution Commending President Biden on the Confirmation of 235 Federal Judges

WHEREAS, faith in the judicial system requires that jurists be qualified and conduct themselves by the highest ethical standards, and is substantially bolstered when the Judiciary looks like the communities that it serves;

WHEREAS, the Democratic Party is committed to the appointment and confirmation of judges who are highly qualified and instill confidence in the Judiciary by ensuring that the cadre of federal judges reflect the diversity of the nation as a whole;

WHEREAS, the professional, experiential, and demographic diversity of President Biden's nominees are unprecedented and include: the first former public defender ever appointed to the Supreme Court of the United States and more than 45 public defenders, more than 25 civil rights lawyers and at least 10 workers' rights lawyers appointed to the federal bench; the first Black woman to serve on the Supreme Court; a record percentage of women nominees (nearly two-thirds); a record number of African American, Latino, AANHPI, Native American, Muslim American and LGBTQ judges; the first Muslim American woman and man, and the first out lesbian to serve on any federal circuit; and more Black women appointed to serve on the federal courts of appeal than every other presidential administration combined;

WHEREAS, a Judiciary that reflects the diversity of our great nation inspires the kind of confidence in the judicial system that is critical to the Judiciary's role of protecting against

overreach and unconstitutional actions by the Executive and Legislative branches of the federal government and by state and local governments;

THEREFORE, BE IT RESOLVED that the Democratic National Committee commends President Biden on the confirmation of 235 diverse and highly qualified federal judges during his term of office; and

BE IT FURTHER RESOLVED that the Democratic National Committee calls on the United States Senate to take seriously its obligation to advise and consent on judicial appointments to assure that the federal bench remains at least as professionally, experientially and demographically diverse as it is today as a result of President Biden's efforts.

Resolution Calling for Reform of the Supreme Court of the United States to Address Ethical Crisis Detailed in the Senate Judiciary Committee Investigative Report

WHEREAS, the Democratic Party has traditionally been, and is, committed to the rule of law and to holding government officials accountable for their actions;

WHEREAS, after a 20-month investigation, the U.S. Senate Committee on the Judiciary, chaired by then-U.S. Senate Majority Whip Dick Durbin, found a consistent stream of ethical lapses by U.S. Supreme Court Justices and repeated failures by the Justices – under the leadership of Chief Justice John Roberts – to in any way address the Court's ethical challenges;

WHEREAS, the Supreme Court of the United States is facing an ethical crisis of its own making which is causing it to lose the trust of the American people, which, in turn, erodes support for the rule of law;

WHEREAS, the highest Court in the land cannot have the lowest ethical standards and the Court has hidden its head in the sand rather than addressing either (1) the failure of Justices, such as Associate Justices Clarence Thomas and Samuel Alito, to disclose lavish gifts from billionaires and others with business before the Court or (2) the failure of Justices to recuse themselves from cases where they have an apparent conflict of interest;

WHEREAS, the ethical lapses uncovered by the Senate Judiciary Committee include: Justice Thomas accepting 258 lavish personal trips, dozens of which were not disclosed; Justice Thomas failing to disclose these and other lavish gifts in violation of federal law; Justice Alito misusing the "personal hospitality exemption" to hide gifts of luxury transportation and lodging in a

2008 Alaska fishing trip; the display of two well-established "Stop the Steal" symbols at the Alitos' properties while Justice Alito actively participated in cases about the 2020 election; and Ginni Thomas, Justice Thomas' wife, paid for efforts involving the "Stop the Steal" movement and other right-wing causes, which created a clear conflict of interest for Justice Thomas under applicable law;

WHEREAS, the Senate Judiciary Committee report recommends that Congress address these concerns by, among other steps, establishing an enforceable Code of Conduct for Supreme Court Justices and a mechanism for meaningful enforcement thereof, and, more specifically:

- "Congress must establish an enforceable code of conduct due to the Court's abdication of its ethical responsibilities to do so.
- The Judicial Conference must be reformed and its internal operations improved, requiring action by Congress as well as internal changes by the Judicial Conference and the Administrative Office of the U.S. Courts.
- Further investigation—ideally with the cooperation of the justices—is needed to understand how the justices allowed these ethical lapses to occur and how to effectively address these failures going forward."

THEREFORE, BE IT RESOLVED that the Democratic National Committee dedicates itself to the rule of law and to holding government officials accountable for their actions by supporting the recommendations of the Senate Judiciary Committee on reforms to the Supreme Court of the United States, the Judicial Conference and the Administrative Office of the Courts to address this ethical crisis; and

BE IT FURTHER RESOLVED that the DNC will advocate for these and other reforms to the Supreme Court of the United States that are aimed at improving the public's perception of the Court as an institution worthy of respect and trust.

Resolution Condemning Political Violence and Promoting Peaceful Political Discourse

WHEREAS, the Democratic National Committee (DNC) is committed to upholding democratic principles, including the right to peaceful assembly, freedom of speech, and civil discourse in the political process; and

WHEREAS, political violence undermines the foundation of democracy, creates divisions within communities, and threatens the safety and well-being of citizens; and

WHEREAS, incidents of political violence and intimidation have demonstrated the urgent need for a unified stance against such actions, in order to foster a safe and constructive environment for political engagement; and

WHEREAS, Donald Trump has repeatedly threatened his political opponents with prosecution and the use of military force, refused to condemn acts of violence on his behalf, used violent and dehumanizing rhetoric about those with opposing political views, and praised perpetrators of political violence; and

WHEREAS, on January 6, 2021, Donald Trump directed a violent mob to march on the Capitol in an effort to overturn the results of a free and fair election, leading to 140 law enforcement officials being injured and police officers losing their lives; and

WHEREAS, not only did Donald Trump refuse to take any action for hours on January 6 as his supporters stormed the Capitol threatened lawmakers, but he has also defended and pledged to pardon insurrectionists who were convicted for their roles in the assault on the Capitol; and

WHEREAS, the DNC recognizes that political violence in any form, including physical attacks, intimidation, threats, and harassment, is antithetical to the principles of democracy and the values of the Democratic Party; and

THEREFORE, BE IT RESOLVED that the Democratic National Committee unequivocally condemns all forms of political violence and intimidation, regardless of ideology or affiliation, and affirms its commitment to ensuring that political processes remain free from violence and coercion; and

BE IT FURTHER RESOLVED that the DNC encourages all political candidates, public officials, party members, and supporters to engage in respectful and peaceful discourse, even in the face of disagreement or protest; and

BE IT FURTHER RESOLVED that the DNC calls upon law enforcement agencies, community leaders, and other political organizations to work collaboratively to prevent violence, de-escalate tensions, and protect the rights of individuals to participate safely in political activities; and

BE IT FURTHER RESOLVED that the DNC supports ongoing efforts to provide education and training on de-escalation, conflict resolution, and nonviolent communication for party members and the public; and

BE IT FINALLY RESOLVED that this resolution shall be communicated to all members of the Democratic Party, shared widely with the public, and reaffirmed as an essential commitment to upholding democratic values and creating a safe and inclusive political environment for all.

Resolution Condemning Violence Against Women and Supporting Efforts to End Gender-Based Violence

WHEREAS, the Democratic National Committee (DNC) believes in the inherent dignity, equality, and rights of all people and is committed to creating a society in which all individuals are free from violence, harassment, and discrimination; and

WHEREAS, violence against women, including domestic violence, sexual assault, harassment, trafficking, and other forms of abuse, continues to harm millions of women and girls in the United States and worldwide; and

WHEREAS, gender-based violence has far-reaching consequences for individuals, families, and communities, impacting physical and mental health, economic stability, and social well-being; and

WHEREAS, women from marginalized communities, including women of color, Indigenous women, LGBTQ+ women, immigrant women, and women with disabilities, often face heightened risk and experience systemic barriers to accessing support and justice; and

WHEREAS, the Democratic Party has long been at the forefront of efforts to combat gender-based violence, from then-Senator Biden writing the groundbreaking Violence Against Women Act signed into law by President Clinton in 1994 to the reauthorization of VAWA in 2022 led by Democrats in Congress and signed into law by President Biden; and

WHEREAS, the Democratic Party remains committed to advancing policies, protections, and resources to prevent violence against women, support survivors, and hold perpetrators accountable;

THEREFORE, BE IT RESOLVED that the Democratic National Committee unequivocally condemns all forms of violence against women and commits to actively working to eliminate gender-based violence in all its forms; and

BE IT FURTHER RESOLVED that the DNC will advocate for robust funding and support for services that assist survivors of gender-based violence, including shelter, healthcare, counseling, and legal assistance, and promote policies that expand access to these services without discrimination; and

BE IT FURTHER RESOLVED that the DNC urges policymakers at all levels of government to prioritize and enact comprehensive legislation aimed at preventing violence against women, protecting survivors, and ensuring that perpetrators are held accountable; and

BE IT FURTHER RESOLVED that the DNC will work to raise public awareness about the prevalence and impacts of violence against women, encourage educational efforts on healthy relationships and gender equality, and promote community-based initiatives focused on prevention and empowerment; and

BE IT FINALLY RESOLVED that the Democratic National Committee reaffirms its commitment to standing in solidarity with women and all survivors of gender-based violence, working to create a safer, more just society where everyone can live free from fear and violence.

Resolution Calling Upon The Members Of The 119th Congress To Respond To The Democratic Will Of The People Of Puerto Rico And Washington, DC By Approving Legislation On The Admission Of Puerto Rico And Washington, DC As The 51st And 52nd States Of The United States Of America

WHEREAS, Tom Perez, Chair of the Democratic National Committee, in 2017 and 2018 announced full Democratic Party support for statehood for the District of Columbia and Puerto Rico, pledging to continue the effort needed to win more Democratic seats in Congress to make Puerto Rico and D.C. statehood a reality that its residents so deserve; and

WHEREAS, the Eastern Regional Caucus of the DNC voted unanimously to make statehood a priority and to create strategies for increased congressional support for the District of Columbia and Puerto Rico at the fall meeting of the DNC in December 2019, and

WHEREAS, on April 22, 2021, the House of Representatives (117th Congress) passed H.R.51 - Washington, D.C. Admission Act, the D.C. statehood bill, for the second time in history with a vote of 216-208. The bill provided "admission into the United States of the state of Washington, Douglass Commonwealth, composed of most of the territory of the District of Columbia. The commonwealth shall be admitted to the Union on an equal footing with the other states"; and

WHEREAS, on December 15, 2022, the House of Representatives (117th Congress) passed H.R. 8393 - Puerto Rico Status Act – providing for a federally sponsored, binding and self-executing

plebiscite vote for the People of Puerto Rico to resolve its political status among the options of statehood, independence, or sovereignty in free association with the United States; and

WHEREAS, the United States Constitution that was ratified in 1788 provided the right to vote for representation in Congress to the "People of the several States" of the United States, which included citizens living on the land that would later be designated by the federal government for the nation's capital as ceded by Maryland and Virginia to become the District of Columbia; however, through the enactment of the "District of Columbia Organic Act of 1801" D.C. residents were disenfranchised from voting for representative Members of Congress more than 200 years ago; and

WHEREAS, Puerto Rico was colonized by Spain in 1493 and became a United States territory in 1898 making Puerto Rico the oldest colony in the world and the longest held territory in the history of the United States; and

WHEREAS, District of Columbia residents pay among the highest per capita federal taxes in the nation, the District of Columbia has a population which is larger than some states, and hundreds of thousands of residents have served in the federal armed services, and yet D.C. residents have no vote in the United States Congress; and

WHEREAS, the residents of the District of Columbia and Puerto Rico lack full democracy, equality, and citizenship enjoyed by the residents of the 50 states; and

WHEREAS, the citizens of the District of Columbia and Puerto Rico continue to express their determination to achieve full representation by electing two United States Senators and United States Representatives to represent them in Congress and achieve full democracy; and

WHEREAS, 3.2 million U.S. citizens live in Puerto Rico-more than in 20 states-but cannot vote for President and Vice President or elect members to the U.S. Senate nor voting members to the U.S. House of Representatives; and

WHEREAS, the majority of the people of Puerto Rico have recently voted for statehood in four locally held plebiscites in 2012, 2017, 2020, and most recently in November 2024, showing their determination to end the current territorial and colonial status relationship with the United States; and

WHEREAS, the residents of the District of Columbia endorsed statehood for the District of Columbia, and in 2016 passed a District-wide referendum advising the D.C. Council to petition Congress to enact a statehood admission act to admit the District into the Union; and

WHEREAS, the 2020 and 2024 Democratic Party Platform announced that Democrats "unequivocally support" statehood for the District of Columbia; and

WHEREAS, the 2020 Democratic Party platform endorsed a guarantee of self-determination for the people of Puerto Rico, and Joe Biden announced during a 2020 campaign event that he believes "statehood to be the most effective means of ensuring that residents of Puerto Rico are treated equally"; and

WHEREAS, the 2024 Democratic Platform acknowledged Puerto Ricans rejection of its current territorial status by stating that "Democrats recognize that the people of Puerto Rico have earned and deserve to resolve the political status question. For this reason, Democrats support the enactment of the Puerto Rico Status Act (H.R.2757/S.3231), and promotes the full civic and political representation for Puerto Ricans"; and

WHEREAS, on November 5, 2024, Puerto Ricans held a plebiscite using the exact same language and definitions included in the Puerto Rico Status Act (H.R. 2757/S.3231) and according to the Puerto Rico Elections Commission 58.48% of voters selected statehood as their preferred option; and

WHEREAS, Democrats recognize that Puerto Rico has rejected its current territorial status, and has earned the right and deserves to be admitted as a state;

THEREFORE, BE IT RESOLVED, that the Democratic National Committee, in recognition of the inherent limitations of Puerto Rico's territorial status and the District of Columbia's limited home rule, and the responsibility of the Federal Government to enable the people to freely express their wishes regarding political status and achieve full self-government, the DNC hereby calls upon the Democratic members of the 119th Congress to respond to the democratic will of the people of Puerto Rico and Washington, D.C. by approving legislation on the admission of Puerto Rico and Washington, D.C. as the 51st and 52nd states of the United States of America.

WHEREAS, he was elected president of the United States in 1976 and served for four years; and

WHEREAS, he led with dignity, decency, and empathy for all Americans, advancing international democracy and human rights and promoting economic and social development; and

WHEREAS, Jimmy Carter was a public servant, leader, and humanitarian whose legacy of kindness, generosity, and charity improved the lives of countless individuals; and

WHEREAS, Jimmy Carter passed away on December 29, 2024, at age 100;

THEREFORE, BE IT RESOLVED, that the Democratic National Committee honors President Jimmy Carter for his contributions to our country, and the Democratic Party offers condolences to his family and friends.

Resolution Honoring the Life and Career of Francis X. Bellotti

WHEREAS, Francis X. Bellotti was born on May 3, 1923, in Boston, Massachusetts and passed away peacefully surrounded by his loving family on December 17, 2024; and

WHEREAS, Frank was the beloved husband to Maggie Bellotti, father to twelve children, twenty-five grandchildren, and eleven great-grandchildren; and

WHEREAS, Frank graduated Boston English High School, class of 1940, Tufts University in 1947, and Boston College Law School in 1952; and

WHEREAS, Frank was a World War II veteran, having served in the United States Navy as an intelligence and athletic officer in the Scouts and Raiders, a precursor to the U.S. Navy Seals. He received the European-African Theater Ribbon, Asiatic Pacific Ribbon (1 Star), a Presidential Unit Citation, and Victory Ribbon WWII; and

WHEREAS, in his illustrious career, Frank marched with Dr. Martin Luther King, protested the war in Vietnam, and fought hard for civil rights, gay rights, consumer protection, and environmental safeguards, long before those became politically fashionable; and

WHEREAS, Frank served as Lieutenant Governor from 1963 to 1965 and went on to serve three terms as Attorney General from 1975 to 1987. As the state's top law enforcement official in the 1970s and 1980s, he was credited with professionalizing an office that became a model for attorneys general across the country and a training ground for dozens of Massachusetts judges; and

WHEREAS, after leaving office, Frank worked in private practice and helped found Arbella Insurance Group, where he served as chairperson, and

WHEREAS, the National Association of Attorneys General (NAAG) established the Francis X. Bellotti award to be given to former state attorneys general whose work has furthered the NAAG mission; and

WHEREAS, in 2012, the Quincy, MA District Courthouse was renamed in Frank's honor; and

THEREFORE, BE IT RESOLVED that the Democratic National Committee honors Francis X. Bellotti for his contributions to our country and the Democratic Party and offers its condolences to his family and friends.

WHEREAS, Bill also served as a trusted staff member for elected officials at both the state and federal levels, including roles as Legislative Liaison for Governor Ann Richards, District

Director for U.S. Congressmen Max Sandlin and Jim Chapman, and consultant for State Representatives Mark Homer, Barry Telford, and State Senator Richard Anderson; and

WHEREAS, Bill has been an inspiration for generations of Texans, and his legacy of dedication, hard work, and service will live on to inspire many more;

WHEREAS, Delahunt was elected and served as United States Representative for the 10th District of Massachusetts for the 105th, 106th, 107th, 108th, 109th, 110th, and 111th sessions of Congress; and

WHEREAS, Delahunt stayed true to his values as a Democrat throughout his service in Congress where he championed issues including clean energy, healthcare, and criminal justice reform, while also using his outsized influence on foreign policy matters to make a difference for his constituents, including by negotiating for discounted home heating fuel from foreign nations and working to improve the bureaucratic hurdles of international adoptions; and

WHEREAS, Delahunt served as interim Director of the Harvard Institute of Politics from 2016 to 2018 where he was celebrated by students and faculty for his commitment to mentoring the next generation of political leadership; and

WHEREAS, his Senate career began in 1997, setting continuance to his extensive presence in Congress for the following decade; and

WHEREAS, his legislative works included the authoring of bills that provided access to water in Indian Reservations in southern South Dakota and rural areas in the state; and

WHEREAS, his efforts in Congress extended to providing clearer labels in food products, expedited advance in funding for veterans' benefits, and new sections of the National Park Service; and

WHEREAS, he served in the Committee on Energy and Natural Resources, Committee on Indian Affairs, and became chairman of the Committee on Banking, Housing, and Urban Affairs; and

WHEREAS, despite going through health difficulties that affected his speech and mobility, he continued serving in the Senate after his recovery for nearly 10 more years; and

WHEREAS, Senator Tim Johnson was a leader, public servant, visionary and educator who dedicated his life to ensuring the improvement of living conditions to the Indian community, expansion of infrastructure, and access to better health care to millions of Americans;

WHEREAS, Tim Johnson passed away on October 8, 2024, at age 77;

THEREFORE, BE IT RESOLVED, that the Democratic National Committee honors Tim Johnson for his contributions to our country and the Democratic Party offers condolences to his family and friends.

governments and corporations to ensure human rights. Within the organization, she demonstrated her commitment to social justice by marching with activist Cesar Chavez, sat with Native Americans at Alcatraz, confronted dictator Arap Moi in Nigeria, and trekked mountainous terrains to visit unjustly convicted prisoners in Mexico; and

WHEREAS, efforts extended to working in social impact in local cities, such as the Bedford Stuyvesant Restoration Project. She also co-chaired the Coalition of Gun Control; and

WHEREAS, she supported Barack Obama in his campaign in 2008. One of her efforts led to raising \$6 million for Obama's campaign in one night. Her efforts and fundraisers also helped Democratic gubernatorial candidates; and

WHEREAS, she was awarded the Presidential Medal of Freedom by President Obama in 2014 in light of her dedication to advancing social justice, human rights, environmental protection and fighting poverty causes; and

WHEREAS, Ethel Kennedy was a leader, visionary, mother, wife and advocate who dedicated her life to serve other leaders and those who are in need; and

WHEREAS, Ethel Kennedy passed away on October 10, 2024, at age 96;

WHEREAS, on August 12, 2008, Congressman Leach broke party ranks by endorsing Democratic presidential candidate Barack Obama over Republican presidential candidate John

Resolution Honoring the Life and Career of Lilly Ledbetter

WHEREAS, Lilly McDaniel Ledbetter was born on April 14, 1938, near Jacksonville, Alabama, and was raised in a small town in the heart of the American South; and

WHEREAS, Lilly Ledbetter was hired in 1979 as an overnight supervisor at the Goodyear Tire & Rubber Company in Gadsden, Alabama, where she initially earned the same salary as her male colleagues; and

WHEREAS, throughout her career at Goodyear, Lilly Ledbetter faced pay discrimination, ultimately earning less than any of the men performing the same work, despite her dedication and recognition with a Top Performance Award; and

WHEREAS, Lilly Ledbetter's discovery of the pay disparity was made possible through the courage of an anonymous individual who provided her with a note listing the salaries of her male counterparts; and

WHEREAS, after uncovering this injustice, Lilly Ledbetter filed a formal complaint with the Equal Employment Opportunity Commission and later pursued legal action against Goodyear, alleging pay discrimination under Title VII of the Civil Rights Act of 1964 and the Equal Pay Act of 1963; and

WHEREAS, the Supreme Court's 2007 ruling in Ledbetter v. Goodyear Tire & Rubber Co. set a precedent limiting the timeframe for filing claims of pay discrimination, which spurred a national movement to address systemic inequities in workplace compensation; and

WHEREAS, Lilly Ledbetter's tireless advocacy for equal pay inspired landmark legislation, culminating in the passage of the Lilly Ledbetter Fair Pay Act, signed into law by President Barack Obama on January 29, 2009, as the first piece of legislation of his presidency; and

WHEREAS, Lilly Ledbetter's unwavering determination to seek justice for herself and countless others has left an indelible mark on the fight for gender equity, ensuring that future generations are empowered to challenge workplace discrimination; and

WHEREAS, Lilly Ledbetter's life exemplified courage, resilience, and a commitment to fairness, inspiring her fellow Americans and advancing the cause of equality across the nation; and

WHEREAS, Lilly Ledbetter passed away on October 12, 2024, leaving behind a legacy of perseverance and advocacy that continues to shape our nation's pursuit of justice;

THEREFORE, BE IT RESOLVED, that the Democratic National Committee honors the life and legacy of Lilly Ledbetter for her extraordinary contributions to the cause of pay equity, gender justice, and civil rights; and

WHEREAS, in 1968, Lucy traveled to Memphis to resolve an impasse between the city and its 1,300 sanitation workers, who were fighting for dignity, respect and union recognition; and

WHEREAS, Lucy would play a key role in their historic strike, helping craft the slogan worn by the strikers, "I AM A MAN", as well as helping negotiate a contract with the city that met the strikers' demands; and

WHEREAS, in 1972, he co-founded the Coalition for Black Trade Unionists (CBTU), which fought to ensure that African Americans have a voice in the trade union movement; and

WHEREAS, in 1984, he co-founded the Free South Africa Movement, which became a monumental grassroots anti-apartheid campaign; and

WHEREAS, in 1994, he led a delegation of the American Federation of Labor and Congress of Industrial Organizations (AFL-CIO) to monitor the South African elections in which Nelson Mandela became president; and

WHEREAS, in 1994, he was elected president of Public Services International (PSI), the world's largest union federation, and later served as vice president of various departments within the AFL-CIO, including industrial union, maritime trades, and professional employees; and

WHEREAS, he was a member of the boards of directors of several civil rights groups, including the African American Institute, Americans for Democratic Action, and the Center for Policy Awareness; and

WHEREAS, Lucy's efforts helped AFSCME grow to more than 1.4 million members across the country; and

WHEREAS, he was one of the most accomplished and influential trade unionists ever, anywhere in the world, as well as a fierce defender of civil and human rights, and his actions had a positive impact on millions of lives and changed the American labor movement forever; and

WHEREAS, Bill Lucy passed away on September 25, 2024, at age 90;

WHEREAS, his legislative work extended to public health, consumer protection, scientific research, foreign affairs, infrastructure, transportation, historical preservation of land; and

WHEREAS, he founded the Congressional Brain Injury Task Force, which extended prevention and treatment of head trauma in athletes and military personnel throughout collaboration in the public and private sector agencies, and

WHEREAS, Pascrell served as one of the original members of the Homeland Security Committee, and was member of the House of Transportation Committee and Chairman of the Oversight Subcommittee on Oversight of the Committee on Ways and Means; and

WHEREAS, Bill Pascrell Jr. was an educator, visionary, and most importantly a leader who impacted the lives of many Americans; and

WHEREAS, Bill Pascrell Jr. passed away on August 21, 2024, at age 87;

Resolution Honoring the Life and Career of Kay Patterson

WHEREAS, State Senator Kay Patterson was born on January 11, 1931 in Darlington County, South Carolina to James and Leila Prince Patterson and was raised in Darlington and Sumter Counties by his paternal and maternal grandmothers, Mrs. Meta B. Patterson and Mrs. Emma Joseph; and

WHEREAS, Patterson was known for his sharp wit and as an outspoken and fiery speaker who, as one of the longest serving leaders in the state's political community, was considered a moving force in promoting and effectuating change in the state; and

WHEREAS, Patterson graduated from Lincoln High School in 1949, attended Claflin College and then served in the Marines from 1951 to 1953 as a sergeant, returning to the state to earn his baccalaureate in Social Sciences at Allen University in 1956, then his Masters of Education from South Carolina State College in 1971; and

WHEREAS, while in college, Patterson cleaned offices at the State Capitol, which because of segregation at the time, he and other Black people could only be if they were working; and

WHEREAS, Patterson was a classroom educator for over 14 years teaching at several schools – W.A. Perry Middle School, C.A. Johnson Preparatory Academy, and Benedict College – and served 16 years as a UniServe Representative for the South Carolina Education Association before retiring in 1986; and

WHEREAS, in 1983, Patterson was selected by the state's House Education Committee to serve on the Board of Trustees for the University of South Carolina, becoming the first Black person to serve on the Board since Reconstruction; and

WHEREAS, Patterson served in the state House of Representatives from 1974 until 1985, at which time, with the urging of U.S. Representative Jim Clyburn, he ran for and was elected to the state Senate where he served until his retirement in 2008; and

WHEREAS, since 1980, Patterson advocated for removal of the Confederate flag from inside the House and Senate chambers long before the flags were taken down in 2000, and from the South Carolina State House dome, initially sponsoring a bill for its removal in 1983, decades before Governor Nikki Haley signed a bill into law in 2015; and

WHEREAS, Representative Jim Clyburn called Patterson, "a trusted leader, a tireless champion for civil rights, and a treasured friend …. a person of strength, determination, [and] wisdom"; and

WHEREAS, the South Carolina Democratic Party said that Patterson "left an indelible mark on our state, … [and he] commanded everyone's attention with his wit and wisdom"; and

WHEREAS, Patterson was married to Jean James of Pinewood, South Carolina and they had two children and three grandchildren;

THEREFORE BE IT RESOLVED, that the Democratic National Committee honors Kay Patterson for his contributions to the State of South Carolina, our country, and the Democratic Party, and offers condolences to his family and friends.

WHEREAS; Sarah-Ann King was born to Norris and Annie Bomar King, on November 6, 1933, in Boston, Massachusetts, and passed away there on March 21, 2024, at age 90. She married Donald Melvin (Kwame) Shaw in 1958, together they lovingly raised their daughter, Klare Elise Shaw; and

WHEREAS; Sarah-Ann graduated from Boston's Girls Latin School and after graduation, briefly attended Boston University. A lifelong learner, she received honorary degrees from Simmons University and Mount Ida College, and induction into the halls of fame of the Massachusetts Broadcasters Association, Action for Boston Community Development (ABCD), as well as a lifetime achievement award from the National Association of Black Journalists in 1998; and

WHEREAS; Sarah-Ann participated in the NAACP Youth Council as a young adult which fueled her civic activism. The group met at the League of Women for Community Service at 558 Massachusetts Ave where she was later a board President. She also received the Thurgood Marshall Lifetime Achievement Award from the Boston branch of the NAACP in 2019;and

WHEREAS; in the early 1960s, Sarah-Ann became leader of the Boston branch of the Northern Student Movement (NSM), an important arm of the Civil Rights Movement. Under her guidance, NSM focused on civil rights, public education, fair housing, and equal employment; and

WHEREAS; Sarah-Ann thrived on arts and culture and learned to dance from Ms. Elma Lewis. As a host of Say Brother, and her own show Mzizi Roots on WBZ-TV that focused on

African-American culture and current affairs, Sarah-Ann highlighted dozens of local and national artists; and

WHEREAS; Sarah-Ann worked at Action for Boston Community Development (ABCD) and helped develop the neighborhood Area Planning Action Councils. Her knowledge of local issues and disinvestment in Black communities led to an invitation to contribute to a national TV show. This led to an opportunity to join "Say Brother," later renamed "Basic Black"-- one of the longest-running local Black shows; and

WHEREAS; in 1969, Sarah-Ann became the first Black female TV reporter in Boston. She was one of the city's most prominent reporters holding that position for 31 years until retirement, she worked on important issues and pushed for equity in every neighborhood of the city; and

WHEREAS; Sarah-Ann was the co-founder of the Boston Association of Black Journalists which honored her with an achievement award in 1993; and

WHEREAS; Sarah-Ann in 2023, was an inductee to the "1965 Freedom Plaza" that surrounds "The Embrace" sculpture on the Boston Common in recognition of her civil rights and media contributions. Also in 2023, the Oscar Micheaux Family Theater gave her one of its First Marian Anderson Women's Tribute awards; and

WHEREAS; Sarah-Ann was an active member of the Ward 12 Boston Democratic Committee and an elected member of the Massachusetts Democratic State Committee where she was committed to diversity, voter registration and turnout, and civic education;

WHEREAS, Cecile Richards was born July 15, 1957, in Waco, Texas to Ann Richards, a teacher turned governor of Texas, and David Richards, a civil rights lawyer who represented labor unions and newspapers; and

WHEREAS, Richards' childhood in Dallas and Austin was filled with politics and social activism from an early age, wearing a black armband to protest the Vietnam War in ninth grade; and

WHEREAS, at age 16, Richards helped her mother in supporting Sarah Weddington's successful campaign for a seat in the Texas House of Representatives, following Weddington's Supreme Court victory as co-counsel for the plaintiff in *Roe v. Wade*; and

WHEREAS, as a history major at Brown University, where she graduated in 1980, Richards pushed for better working conditions for the school's janitors and skipped her commencement ceremony in protest of the university's investments in South Africa during apartheid; and

WHEREAS, following college, Richards became a labor organizer for hotel workers in New Orleans, where she met her future husband, Kirk Adams; and

WHEREAS, when her mother Ann decided to run for governor, Richards and her husband moved to Austin to help with her election in 1990; and

WHEREAS, Richards served as deputy chief of staff for Representative Nancy Pelosi when she was named minority whip in 2001; and

WHEREAS, Speaker Emerita Pelosi commented on Richards' "sharp intellect, strategic thinking and relentless effectiveness," and said she would be remembered "as a commanding leader in her own right, whose good works have improved countless lives all across the country"; and

WHEREAS, Richards served as president of Planned Parenthood for 12 terms, from 2006 to 2018, overseeing its evolution to what the New York Times described as "a potent political organization and the country's largest provider of reproductive and women's sexual health care"; and

WHEREAS, when President Joseph R. Biden awarded Richards the Presidential Medal of Freedom on November 20, 2024, he called her "a leader of utmost character," and noted that she "led some of our nation's most important civil rights causes – to lift up the dignity of workers, defend and advance women's reproductive rights and equality, and mobilize Americans to exercise their power to vote"; and

WHEREAS, Richards was diagnosed in 2023 with glioblastoma, an aggressive form of brain cancer, and passed away on January 20, 2025 at her home in New York City at the age of 67; and

WHEREAS, Richards is survived by her husband, three children, sister, two brothers, and a grandson;
